National Student Poetry Competition to be Broadcast Live

Poetry Out Loud — a partnership of the National Endowment for the Arts, Poetry Foundation and state and jurisdictional arts agencies — will hold its **national semifinals and finals** virtually this May. Designed to celebrate dynamic poetry recitation from top high school students across the country, the semifinals on **May 2** will feature 55 finalists, and the top nine students from that competition will advance to the **May 27** finals to compete for \$50,000 in awards and stipends.

National Grant Organization Offers Virtual Learning Opportunity on Arts and Juvenile Justice

Grantmakers in the Arts will host its next webinar, "Advancing Art & Advocacy: Abolition Opportunities in Juvenile Detention," on **April 27 at 2 p.m. EDT**. Intended for emerging and experienced grantmakers with information and discussions that inform their day-to-day practices, this webinar will discuss the Art for Justice Fund, a five-year initiative that is disrupting mass incarceration by funding artists, youth activists and advocates who are working together to reform the justice system. **Register today!**

Educational Research Grant Program Accepting Applications

The American Educational Research Association will continue to offer its **research and dissertation grants program**. Made possible by National Science Foundation (NSF) funding, the grants program provides small grants and training for researchers who conduct studies of education policy and practice using quantitative methods and including the analysis of data from the large-scale data sets sponsored by National Center for Education Statistics (NCES) and NSF. **Deadline: May 12.**





National Education Policy Organization Offers COVID-19 School Reopening Resources

Call for Proposals Opens for Global Humanities Symposium

The Meridian Center for Cultural Diplomacy and the National Endowment for the Humanities are now **accepting proposals** for the "2021 Global Humanities Symposium: Observing Cultural Diplomacy." To be held virtually on **June 11**, the inaugural symposium is open to early to mid-career professionals, including post-doctoral fellows, professors of practice, independent scholars, professionals outside of academia and those in early-stage academic positions. Proposals should focus on the idea of "Observe," one of the foundational processes in building bridges across cultures. Interested presenters must submit 250-300 word abstracts and other materials by **April 30**.

Documentary Film Foundation Teams Up with Film Festival to Support Black Directors

North Carolina-based Working Films and the Cucolarus Film Festival are **now accepting applications** for the 2021 Works in Progress (WiP) Lab. The Lab supports social justice documentaries being made by Black filmmakers. Eligible filmmakers selected to participate will attend a weeklong residency in Wilmington, North Carolina, which will include trainings, workshops and screenings before and during the annual film festival to be held this November.
