Federal Department of Education Announces Actions to Advance Equity in Education

The U.S. Department of Education recently **announced a series of actions** it will take to advance equity in education and ensure schools across the nation are serving all students. From a report highlighting the disparate impacts of COVID-19 on K-12 and postsecondary students in underserved communities and guidance to implement a historic provision within the American Rescue Plan that will ensure that the school districts with the highest poverty do not

receive any per-pupil decrease in state funding below their pre-pandemic levels to news of an Equity Summit Series the Department will host, these actions aim to address inequities exacerbated by the COVID-19 pandemic and to encourage schools more broadly to reimagine their education systems and practices and infuse equity into all of their work.

Up to two award winners will receive a one-time grant of \$5,000 for use in continued college-level or trade-related studies, a travel stipend to attend The NAMM Show in Anaheim, California, and a one-year mentorship through the NAMM Young Professionals organization. Grants Now Available for Filmmakers



The Roy W. Dean Film Grants program is now accepting submissions for its Summer Grant Award. Winners will receive a cash award, goods and discounted services offered by film industry companies and professionals committed to helping good films get produced.

As part of its Get Creative program, The Lyric will offer two online summer workshops for students entering grades 6-9. Children and Youth Eco-Art Competition Opens Call for Entries

EarthX — an international environmental nonprofit dedicated to educating/inspiring action for a sustainable future — is now accepting submissions for its Plant the Seed Eco-Art Competition 2022. Eligible young artists ages 5-22 can submit artwork, either 2-D or 3-D, that illustrates the message of the "Plant the Seed" theme. Contestants can use any medium or combination of media as long as the work meets the size requirements designated in the competition rules. **Deadline: Jan. 24, 2022.**
