# FROM AEP DIRECTOR, JAMIE KASPER

#### AEP PARTNERS AND FRIENDS,

Happy new year! As we transition into 2020, I wanted to take the time to reflect on the past year. For myself, 2019 brought a whirlwind first three months in my tenure as director of the Arts Education Partnership. For AEP, 2019 brought change, new opportunities and significant growth.

#### In 2019, AEP:

- Added two new staff positions.
- Published five new reports.
- Welcomed six new partner organizations.
- Added 17 new studies to ArtsEdSearch.
- Received increased funding from the National Endowment for the Arts and U.S.
   Department of Education for the second year in a row.

But this growth doesn't encompass the full story of AEP's year; change was also a theme. In 2019, AEP gained four new staff members, and one staff member changed positions. Five of AEP's six staff members are new to their positions! It's a wonderful opportunity to enter 2020 with renewed energy and direction to serve our partners.

As part of my initial time at AEP, I've interviewed our advisory council members and revised AEP's strategic mission based on their feedback. We heard that the best way for AEP to effect change in arts education is to focus on serving leaders in the field and providing unbiased, robust information about policy and practice to help support impactful, equitable decisions that affect learners across the country. To do this, AEP will be more purposeful in 2020 about aligning our work to Education Commission of the States' framework for service: research, report, convene and counsel. All of AEP's products and services fit into this framework, and this intentional focus will allow us to better communicate how we can serve the field and the impact of our work over the next year and beyond.

I hope you enjoy exploring this look back on 2019 as much as I did. All of us at AEP look forward to working with you in 2020!



# 2019 RESEARCH



In collaboration with the State Education Agency Directors of Arts Education, we completed a comprehensive review of state education statutes and codes related to the arts in education across all 50 states and the District of Columbia. We used the results of this review to update <u>ArtScan</u> – an easy-to-use and searchable database that provides the most current information on combined policy areas related to K-12 arts education. Users can explore the data through state-level profiles for all policy areas and several types of 50-state reports. Coinciding with the update to ArtScan in March, we released the <u>2019 ArtScan at a</u> <u>Glance</u>, which summarizes policies for arts education for all 50 states and the District of Columbia.

# **QArtsEdSearch**

<u>ArtsEdSearch</u> is an online clearinghouse of more than 280 research studies focused on the outcomes of arts education for students and educators, both during and outside the school day. Visitors to the website can search for research using a variety of methods, including refining searches by criteria related to outcomes for students, teachers and schools; age levels; art discipline and research type. Through ArtsEdSearch, we compile, summarize and organize research conducted on the impact of the arts in education to continue to inform policies and practices.

# 2019 REPORT

#### Reports

We focus on providing partner organizations and arts education stakeholders with relevant reports and publications demonstrating the contributions of the arts to student success. Through these resources, we provide objective and nonpartisan information and analysis about key state policy issues in an accessible format. We connect research and policy information related to the arts in education and engage in a robust dissemination strategy to share these resources widely with policymakers and all stakeholders.

#### ESSA: Mapping Opportunities for the Arts



This <u>multi-chapter, special report</u> highlights the ways states and districts can engage the arts in the ongoing work of ESSA. In 2019, we updated this report with a new chapter on Title IV. We also provide <u>abbreviated versions of each of the eight chapters</u>. In partnership with the ESSA Working Group, we continue to update this resource to provide timely information for arts and education stakeholders to utilize.

#### **Policy Considerations for STEAM Education**



This **Policy Brief** highlights state policies and practices — including access efforts, federal and state funding, and statewide coordination — that can help states to advance STEAM (science, technology, engineering, arts and math) education and increase student participation.

We also created a **<u>companion infographic</u>** that outlines the components of STEAM education.

#### **Visual Arts Matter**



<u>This resource</u> explores how visual arts support students' academic success both within and outside of school settings by cultivating learning skills, boosting academic achievement and enhancing the educational experience of traditionally underserved students.

#### The Arts in Schools of Choice



This **Policy Brief** highlights how states currently address schools of choice within policy, including those that intersect with arts education, and explores further opportunities to engage the arts in statewide policies and practices.

#### Preparing Students for Learning, Work and Life Through STEAM Education



This **Policy Brief** shares insights from a recent Thinkers Meeting that looked beyond existing state policies and explored new pathways to guide future practice, research and policy work to support access to STEAM education for all students.

#### **Information Requests**

One of the ways that we serve as a resource to states and provide assistance to our partner organizations and other arts and education stakeholders is by responding to arts education-related information requests submitted to Education Commission of the States.



In 2019, we responded to four information requests concerning <u>accountability</u>, <u>existing research</u>, <u>funding</u> and <u>state</u> <u>policies</u> in relationship to the arts in school choice. We also responded to requests for information on research related to arts education policy trends, career and technical education, music education and STEAM education.


Priority Area 1: Raise Student Achievement and Success: Expanding Literacy Through Art.

# 2019 CONVENE DIG

#### **Arts Education Policy Briefing**

On March 3, we collaborated with Americans for the Arts to facilitate and program the Arts Education Policy Briefing in the District of Columbia. The event took place in advance of the National Arts Action Summit, and our partner organizations joined AFTA state network members to participate in the day-long conference. Programming included a 'State Policies to Support STEAM Education' panel discussion — featuring Sen. Joyce Woodhouse of the Nevada State Legislature, Heather Sherman of the Ohio STEM Learning Network and Alysia Lee of the Maryland State Department of Education — and two roundtable discussions focused on our new STEAM resources and the arts in schools of choice.

#### **STEAM Thinkers Meeting**

On June 11-12, we convened 11 researchers, policymakers and practitioners from across the country to participate in an invitation-only Thinkers Meeting on STEAM education. Participants discussed policy opportunities for the arts in STEM, workforce demand for STEAM skills and careers, and the unique value that the arts and STEM bring to one another. Our <u>Preparing Students for</u> <u>Learning, Work and Life Through STEAM Education</u> Policy Brief shares highlights from participants conversations and insights.

#### Education Commission of the States' 2019 National Forum on Education Policy

The 2019 National Forum on Education Policy took place July 10-12 in Denver and convened top experts to discuss key education topics. As part of the programming, we facilitated a panel discussion on state policies supporting STEAM education, with Nevada Sen. Joyce Woodhouse and Heather Sherman of the Ohio STEM Learning Network as speakers.

Conference materials provided more than 600 education policy stakeholders in attendance with the opportunity

to learn more about STEAM education and policy opportunities to increase access to arts learning in STEM education.

#### 2019 AEP Annual Convening

The 2019 AEP Annual Convening took place Sept. 11-12 in Alexandria, Virginia, and welcomed more than 200 attendees from 38 states. The event included 15 concurrent sessions exploring key issues spanning diversity, equity and inclusion; arts education data and research; and promising practices in the field.

Programming also included keynote remarks from Virginia State Superintendent of Public Instruction James Lane; a panel discussion featuring leaders in STEAM education who shared their experiences and perspectives on the role that cultural institutions can play in providing culturally relevant STEAM instruction; and the "A Long Conversation: Equity in the Arts in Education" plenary session, which brought together eight leaders in diversity, equity, inclusion and access to discuss opportunities for arts and education leaders.

#### Feedback From Participants:

- •More than 87% of respondents rated the event as either 'Very Good' or 'Excellent'.
- •More than 77% of respondents characterized the content of the meeting as 'Relevant' to their work.

#### **Equity Toolkit Focus Group Meeting**

Following the 2019 AEP Annual Convening, we hosted a two-day, focus group meeting to build on the AEP Equity Working Group's idea of creating an equity toolkit for the field. The meeting brought together arts and education leaders (outside of the Equity Working Group) to discuss what they would want to see in a toolkit and its potential value to the field. Participants represented the District of Columbia, Idaho, Minnesota, Nebraska, New Jersey, New York and Utah.

#### ArtsEd Digest

We continue to disseminate our bimonthly ArtsEd Digest newsletter, which highlights events, news and resources from AEP, our partner organizations and the arts in education field.

#### **Social Media**

#### Website

Our website provides our partner organizations and other arts and education stakeholders with access to a comprehensive collection of research, reports and other resources exploring key issue areas across the arts education field, including state- and federal-level policies related to the arts in education. In September, we launched a full redesign of our website, which features updated navigation and improved usability to increase utilization and searching of all of our resources.
