FROM AEP DIRECTOR, JAMIE KASPER

AEP partners, affiliates and colleagues,

Wow. What a year 2020 was for all of us. Like most of you, AEP staff members in both the Denver and D.C. offices transitioned suddenly to working from home. We had to figure out how to communicate — both internally with staff and externally with partners — without access to the ubiquitous coffee meeting. We had to redefine our system for collaborating on materials. We were assisted by having project management software but needed to commit some time reconfiguring how our work got done. And during it all, D.C. staff moved all their things out of the offices in WeWork and into a new dedicated office suite in a building down the street.

2020 wasn't all about the COVID-19 pandemic for us, though. It was also the 25th anniversary of AEP's founding, and Education Commission of the States successfully recompeted to remain the home of AEP. We were still able to connect with over 400 attendees — more than twice the usual attendance at the in-person annual convening — when we hosted our virtual gathering in September. In concert with the virtual gathering, we released "Reflecting Back and Projecting Forward: 25 Years of the Arts Education Partnership." This history document, chronicling the people and policies that led to AEP's founding in 1995, was the result of work by numerous people who played critical roles in those early years. I am so proud of the document and thankful for the work of the authors and contributors, as well as the designers from the ECS team who made our vision a reality. I'm also grateful for the support of the National Endowment for the Arts and U.S. Department of Education throughout those 25 years, including increased funding for each of the past three years.

AEP adopted a new **strategic mission** at the beginning of last year, focusing our work on building leadership capacity and knowledge for arts and education leaders. AEP staff members helped to build leadership capacity by responding to information requests, providing technical assistance and connecting partners and affiliates to the people and information they need to do their best work. I feel like we were successful in our role as a connector this year, despite all the challenges.

One of our team members recently heard the phrase "I'm doing my situational best." I will steal that phrase to say that in 2020, the AEP team did their situational best, and we are extremely thankful we had the support and capacity to accomplish all we did last year.

Licensure for Non-Arts Teachers




Licensure for Arts Teachers



QArtsEdSearch

ArtsEdSearch is AEP's research database, compiling more than 300 studies and indexing them to improve searchability. ArtsEdSearch users can search for studies by keyword or by choosing criteria such as outcomes, age levels, arts disciplines and research types. In 2020, AEP completed an internal ArtsEdSearch review and convened a new ArtsEdSearch task force for the purpose of improving this popular resource.

Upon recommendation of the ArtsEdSearch Review Panel, AEP added 16 new studies to the database this year.

In addition to presentations, AEP invited partners and affiliates to engage in brainstorming sessions. Participants brought ideas to these sessions for workshopping with staff members. Local Learning: The National Network for Folk Arts Education and State Education Agency Directors of Arts Education took advantage of this counsel opportunity.

2020 CONVENE

AEP brings arts and education leaders together to **INTERACT**, **COLLABORATE** and **LEARN** from each other. In 2020, "convene" took on a new meaning as in-person interactions moved to a virtual space.

Juvenile Justice Thinkers Meeting

AEP hosted a series of sessions for the Juvenile Justice Thinkers Meeting in July, converting what has traditionally been an in-person event to an online format. AEP convened 11 researchers, practitioners and policymakers from arts, education and juvenile justice contexts for three small-group sessions and one whole-group session. Staff members synthesized findings from pre-meeting surveys and the four sessions into a report, Expanding the Arts Across the Juvenile Justice System.



Virtual Gathering

The AEP Virtual Gathering replaced the Annual Convening and occurred on September 9, 11, 15 and 17. AEP staff members worked closely with the ECS Convene team and consultants from Cvent, MiMedia and LightWell Coaching + Consulting to adjust to a virtual event. Consultant Neon Rain provided additional support in preparing the AEP website to host archived event content.



The event featured 51 speakers and offered participants 81 office hours sessions. 641 individuals registered for the virtual gathering. Of the 641 registered attendees, 416 were active users, meaning they logged into the event website and engaged with the content in some way. All 50 states had at least one active user, in addition to users from five different countries (Austria, Morocco, Germany, South Africa and the United Kingdom).

The event opened with welcome videos from Mary Anne Carter, chairperson of the National Endowment for the Arts, and Christopher Rinkus, deputy assistant secretary at the U.S. Department of Education. Keynote speakers included Janel George, senior policy advisor at the Learning Policy Institute, and Paul Siefkin, president of Fred Rogers Productions. Sharing sessions focused on federal policy, arts education practice in schools and community spaces, juvenile justice, youth leadership and equity. Historical and current leaders presented a long conversation focused on the past and future of arts education, and Institute for the Future facilitated the final session focused on planning for a vision of arts education.

Partner Webinars

AEP started a new quarterly partner webinar series in April. Partner webinars are designed to connect partners and affiliates both to AEP and to each other. A typical partner webinar starts with brief updates from AEP and its federal partners, with the bulk of the time spent in breakout sessions with partners and affiliates sharing their work.

Attendance at these webinars continues to grow. The first webinar in April hosted 34 attendees, while 59 people participated in the second webinar in July. November's webinar attendance was 37.

Working Groups

In 2020, AEP continued to convene the three existing working groups virtually.

EQUITY WORKING GROUP

Chaired by Pam Breaux from the National Assembly of State Arts Agencies, this group reformed as an inquiry-based professional learning community. Participants created inquiry questions related to equity and are working in small groups to investigate those questions, try out new ideas in their organizations and bring their learnings back to the group. The new AEP Equity Working Group Resources page on the website will feature ongoing information from this group.

ESSA WORKING GROUP

Chaired by Heather Noonan of the League of American Orchestras and Narric Rome of Americans for the Arts, this group merged with the arts education working group of Americans for the Arts. The new group — the arts education policy working group — will focus on both federal and state policy.

HIGHER EDUCATION WORKING GROUP

Chaired by Martha McKenna of Lesley University, this group collaborated with AEP on an arts integration blog series for the Education Commission of the States Ed Note blog. AEP published two posts in 2020; these posts will continue through 2021.
