The deadline for the **Research Grants in the Arts** is fast approaching. Research Grants in the Arts support research studies that

investigate the value and/or impact of the arts, either as individual components of the U.S. arts ecosystem or as they interact with each other and/or with other domains of American life. The National Endowment for the Arts welcomes research proposals that align with at least one of the priority topics and possible questions within the agency's FY 2022-26 research agenda.

First submission is due March 25.
