### Call for Proposals Opens for Community Arts Education Conference

The National Guild for Community Arts Education **seeks session proposals** for its Groundwork: Healing for Community Arts Education virtual gathering. To be held over three weeks this October and November, the gathering will focus on learning content tracks such as the General Assembly Track on Healing, Creative Aging Track, Human-Centered Leadership and Management Practices Track, and Creative Youth Development Track. Reviewers encourage proposal submissions that reveal the genuine stories of practice in action, do not shy from real talk, and demonstrate the truth and vulnerability that working in authentic relationship with community requires. **Deadline: July 27.**

### Arts Educator Leadership Training Program Accepting Applications

Arts Education in Maryland Schools is **now accepting applications** for its Arts Education Campaign School, a multi-year professional development program. Black Girls Who Paint (BGWP) is currently accepting submissions for its **Fall '21 Student Award** scholarship. Open to Black students between the ages of 17-21 currently enrolled at least part-time in a visual arts program, the \$1,000 academic award will go to two students and will help offset the cost of art supplies, program fees, food, academic expenses and more.
